We are also bringing together leaders from industry, government and academia through the Trash Free Seas Alliance to lead to innovative solutions that stop trash and plastic at the source.

Then by majority vote of the disinterested Directors (even if the disinterested Directors constitute less than a quorum) it will be decided whether an actual or potential conflict of interest exists or can be reasonably construed to exist. Proposals to the full Board of Directors as to how the conflict of interest should be resolved will then be provided.
