Dear Leader Schumer and Speaker Pelosi,

As you consider final legislation for the 117<sup>th</sup> Congress, we write to express our sincere support for including critical ocean legislation in an end-of-year package. There are several key bipartisan bills we encourage you to pass into law by the end of the 117<sup>th</sup> Congress. These bills, if enacted, will help strengthen the U.S.'s ability to protect the ocean through responding in coordinated ways to address pressing coastal issues, protect vulnerable species and ecosystems, collect critical data that helps us better understand our ocean environment and respond to extreme weather, and ensure greater transparency through publicly accessible data.

We encourage you to include the following bills in an end-of-year package:

- Regional Ocean Partnership Act would formalize regional ocean partnerships (ROPs) as collaborative partners with federal agencies and secure more predictable funding to advance collaborative regional ocean efforts. ROPs are governor-created, regional organizations that collaborate with states, Tribes, federal agencies, and other ocean users to address ocean and coastal issues of common concern.
- Marine Mammal Research and Response Act would strengthen the U.S. government's
  efforts to protect marine mammals like manatees, dolphins, orcas, sea lions, and sea
  otters. This legislation would reauthorize the John H. Prescott Marine Mammal Rescue
  Grant Program, which provides funding for organizations who rescue and rehabilitate
  injured or sick marine mammals.
- **Restoring Resilient Reefs Act** would reauthorize the Coral Reef Conservation Act of 2000, strengthen NOAA's Coral Reef Program, and give resources to non-federal partners to support coral reef conservation, management, and stewardship.
- Bolstering Long-Term Understanding and Exploration of the Great Lakes, Oceans, Bays, and Estuaries (BLUE GLOBE) Act would expand research, increase data collection and monitoring, deploy new technologies, advance the blue economy, and accelerate the dissemination of data to create a greater understanding of the nation's ocean and coastal ecosystems.
- National Ocean Exploration Act would authorize the National Ocean Mapping, Exploration, and Characterization Council, elevate and update ocean science priorities, and direct the Council to coordinate and facilitate activities across federal and non-federal entities to advance those priorities.
- Learning Excellence and Good Examples from New Developers (LEGEND) Act would improve weather modeling and forecasting by requiring NOAA to increase public accessibility of its models.
- Shark Fin Sales Elimination Act would promote shark conservation by making it illegal to possess, buy, sell, or transport shark fins or any product containing shark fins and imposes penalties and fines for each violation.

• The Driftnet Modernization and Bycatch Reduction Act would end the destructive use of large mesh drift gillnets in U.S. waters and save countless whales, dolphins, sea turtles, sharks, and sportfish. These mile-long, nearly invisible nets drift overnight to catch swordfish off California, but entangle, injure, and kill more than 70 other species of commercially viable fish.

We encourage you to include all eight bills in an end-of-year package and vote for their passage. Thank you for your consideration of this request.
